

WHY BOTHER?



Masking real data, Reduces risk.

Developers, testers, trainers and contractors need increased access in Sandbox to deliver new features faster.

However, your Salesforce sandboxes carry real production data and the less hardened security controls can be a recipe for disaster.

Personal Information(PI) in sandbox increase risk of unintended email blasts to malicious data breaches.

Masking removes all personal and business sensitive data from your sandboxes.

No real data in sandbox mitigates data privacy risks and accelerates new feature delivery, testing and training.

Review this checklist to see if your sandbox data is at risk. A score of 6 or above is high risk.

Does your sandbox have real unmasked personal & business sensitive data that makes it vulnerable to data breach?
Do you have full and/or partial copy Sandboxes?
Do the Sandboxes have 'as-is' customer data e.g. Contacts, Leads, Person Accounts?
Do the Sandboxes have 'as-is' business sensitive data e.g Accounts, Opportunities, Quotes?
Do you need to comply with multiple privacy laws (GDPR, CCPA, LGPD) due to the global use of your Salesforce?
Are your customers in Salesforce spread globally esp. EU, USA, Brazil etc. or are they limited to one region?
Is your current data security NDA/contractual only, or do you have more security controls?
Do you have Sandbox users that are not your Organization's employees?
Do these users log into sandbox with just username/password (Uncheck if they have to use SSO, VPNs etc)?
Can they see & download your customer's personal data, run reports & send emails without your admin's knowing it?






